## IMPLEMENTATION ORDER FOR THE RENEWED ORDER PURSUANT TO RULE 8.66 OF THE CALIFORNIA RULES OF COURT

## THE COURT:

On April 15, 2020, Chief Justice Tani G. Cantil-Sakauye, Chair of the Judicial Council, authorized this court to renew the emergency order that extends time periods specified by the California Rules of Court. Pursuant to that authorization, the Court orders as follows:

All time periods specified by the California Rules of Court that occur during the time period between April 20, 2020, through and including May 18, 2020, are hereby extended for 30 days from the date of the specified event. No application for an extension of time shall be required. The extension will be granted irrespective of whether a party received an automatic extension pursuant to the initial emergency order. This extension applies to time periods pertaining to finality of a decision where finality is not immediate under the California Rules of Court, except that the time to file a petition for rehearing or a request for publication and the date of finality shall not, under any circumstances, be extended by more than a total of 30 days. The Court retains the discretion to disallow an extension of time, to order that an action be taken or an event occur within a specified time frame, or to vacate this order should conditions justifying this order abate.

THIS ORDER IS EFFECTIVE IMMEDIATELY.
